

We improve the health of our community by providing affordable and equitable medical, behavioral, and dental healthcare for all.

Welcome from our CEO and Board Chair





At Mountain Family Health Centers, we believe in ensuring health for all. We do this by providing equitable and affordable medical, behavioral, and dental healthcare for more than 24,000 people in Western Colorado. Mountain Family's ten integrated health centers, located across Garfield, Eagle, and Pitkin Counties, and more than 200 dedicated providers and staff offer culturally responsive and equitable healthcare to all, regardless of race/ethnicity, gender identity, sexual orientation, income, or insurance status.

Unfortunately, too many people in our community remain uninsured today, including 39% of Mountain Family patients. To help patients obtain affordable health insurance, Mountain Family employs a bilingual Outreach and Enrollment team that assists patients with enrollment in Medicaid, Child Health Plan Plus, private insurance, or Mountain Family's Sliding Fee Scale Discount Program.

Thanks to our funding partners, donors and community, we can offer innovative and responsive primary, behavioral, dental, and pharmacy care. It is an honor and privilege to share with you this annual report which showcases our growth, our depth, and our unwavering commitment to ensuring healthcare for all.

We are also pleased to share our excitement about our newest community health centers located in the towns of Avon and Gypsum, where we will ensure health for thousands more Eagle County residents in the coming years.

Since 1978 Mountain Family has been honored to provide primary care in our mountain region. We look forward to continuing to care for our community in the coming years, grounded in our vision of ensuring health for all.

Medical Services

PREGNANCY CARE

Timely prenatal, delivery, and postpartum care are essential for the health of women and their babies. Perinatal care is available at all our health centers, with full obstetrical care and deliveries provided via our Avon and Gypsum clinics. The care teams at these two health centers care for over 33% of Eagle County's pregnant women and their children, as well as over 45% of high-risk prenatal patients.

PEDIATRICS

Mountain Family has expanded our Pediatric Program to increase access to affordable, culturally and linguistically responsive pediatric services for children, youth and their families. This includes acute and chronic healthcare, well-child visits and immunizations, and developmental screenings to name a few. All children ages birth to five are screened and those who may have developmental delays are then referred to our community partners who provide developmental support services.

SCHOOL-BASED HEALTH CENTERS

Students attending school at Eagle County and Roaring Fork Schools can access affordable, integrated primary care at one of our five school based health centers. Assistance in enrolling in insurance or financial assistance programs and connecting with resources to address social needs such as food insecurity are also provided. Students and their families who require more complex care can also access our integrated health center hubs.



Dental

We are excited to welcome our new dental director, Dr. Aaron McCormick to the Dental Team. Dr. McCormick has been instrumental in expanding the Dental Team and services at Mountain Family's health centers.

Behavioral

The Behavioral Health Program at Mountain Family continues to grow to better meet the significant need in our region. Our Behavioral Health Team now includeds 14 providers, including psychiatric nurse practitioners, mental health and substance use disorder providers, and behavioral health advocates. Many are bilingual in Spanish.

This past year, we implemented substance use disorder groups in collaboration with Probation in Rifle and implemented Zero Suicide initiatives throughout the organization. Several providers were trained in trauma and EMDR (Eye Movement Desensitization and Reprocessing) therapies to increase therapeutic methods available to patients.



Pharmacy Services

Mountain Family's Pharmacy Program has grown, with medication services now provided at our three health center hubs. In FY 2022-23, we served more than 800 patients and dispensed more than 3,000 prescriptions at these clinics.

We utilize the federal 340B Drug Pricing Program to provide discounted medications. Additionally, the Pharmacy Team connects patients with medication assistance programs, completing prior authorizations, and communicating with retail pharmacies to improve patient access and care. We look forward to expanding clinical pharmacy services in the future to further provide integrated, quality care for our patients.

AVON

In January 2023, Mountain Family relocated and expanded our Edwards health center. The new Avon Integrated Health Center is better suited for the provision of the full range of integrated primary care, with ample space for medical, behavioral, preventative and treatment dental, and pharmacy services.

GYPSUM

In August 2023, we opened the Gypsum Integrated Health Center, which also provides the full range of integrated primary care and is located near an ECO Transit bus stop. Here, providers can care for 3,500 patients annually. Mountain Family is pleased to be able to ensure health for all by increasing access for our neighbors who live and work in Eagle County at these two new health centers.





Total Revenue




Total Expenses

Health For All Fund

The Health For All Fund provides essential unrestricted support so all residents of our region can access the healthcare they deserve. Launched in 2021, our Health For All Fund closed its third year with generous contributions of \$222,623. We offer our heartfelt thanks to the three families who stepped forward to create a \$75,000 matching gift that inspired others to give and helped us reach our goal.

Mountain Family is so grateful for the support of all our donors. Thank you!

However, our work is not done. Sustainable funding continues to be an issue as 30% of our patients are enrolled in Medicaid and 39% do not have health insurance or the means to pay for their care. In addition, we anticipate more people becoming uninsured as they lose their Medicaid eligibility due to the Medicaid reauthorization required with the close of the COVID Public Health Emergency in May 2023.

GIFTS MAY BE ELIGIBLE FOR THE ENTERPRISE ZONE TAX CREDIT

To encourage economic growth, the State of Colorado has designated Mountain Family's health centers in Garfield County as an Enterprise Zone Contribution Project. Colorado residents who make a qualifying Enterprise Zone gift of \$50 or more to Mountain Family's Garfield County operations are eligible for a tax credit of up to 25%. The maximum tax benefit is \$100,000. Please indicate "Garfield County Enterprise Zone" when making your gift to be eligible for this credit.
